ORDER

In response to the evolving public health emergency created by COVID-19 and the actions taken by national, state, and local officials, the Hamilton County Court of Common Pleas, General Division and the Hamilton County Municipal Court (the "Courts") have implemented measures to mitigate the health risk to the public, Court staff, and all courthouse visitors during the pandemic. As we track this evolving health emergency, the Courts will continue to take necessary measures to comply with public health orders and guidelines.

As of late last week, new public health data led the Ohio Department of Health to designate 12 counties as being in a "Red Alert Level 3 Public Emergency" as defined by the Ohio Public Health Advisory System. That system was created to provide local health departments, community leaders, and the public with data and information on the severity of the COVID-19 spread in each Ohio county. The system consists of four levels with specific risk-level guidelines. Each level is calculated with data gathered on seven public health indicators.

In addition to social distancing and wearing a face covering, other guidelines for a Red Alert Level 3 are:

- (1) Decrease in-person interactions with others;
- (2) Consider necessary travel only; and
- (3) Limit attending gatherings of any number.

Three Red Alert Level 3 counties marked with a star (*) are on Ohio's Watch List as they are approaching the highest risk level, Purple Alert Level 4 (stay at home/necessary travel only). Hamilton County and neighboring Butler County are two of three counties on Ohio's Watch List.

In light of the developments in local conditions, and having consulted with Hamilton County criminal justice stakeholders, the Courts are temporarily pausing jury trials (petit jury service) to facilitate the recommended public health emergency guidelines. The Courts will continue to monitor this fluid situation and will resume jury trials when conditions in Hamilton County improve.

With regard to criminal matters, due to the effect of public health recommendations on the availability of counsel and court staff to be present in the courtroom, the continuances implemented by this Joint Administrative Order, are subject to R.C. 2945.72(H), "Extension of Time for Hearing or Trial" and with regard to all matters continuances are subject to AM. SUB. H.B. 197 § 22. The Court specifically finds the public health interests are paramount and the ends of justice are best served by this Joint Administrative Order. To the extent this Order conflicts with any of the Courts' previous COVID-19 related Administrative Orders, this Amended Joint Administrative Order supersedes.

In response to the evolving public health emergency created by COVID-19 and the actions taken by national, state, and local officials, the Hamilton County Court of Common Pleas, General Division and the Hamilton County Municipal Court (the "Courts") have implemented measures to protect the public, our staff, and all courthouse visitors during the pandemic. We have consulted with our county health department to ensure that we are conducting operations, including jury trials, consistent with current health guidelines and best practices. As we track this evolving health emergency we will continue to take necessary measures to keep our staff and the public safe.

Governor DeWine recently announced the creation of the Ohio Public Health Advisory System to provide local health departments, community leaders, and the public with data and information on the severity of the COVID-19 spread in each Ohio county. The system consists of four levels with specific risk-level guidelines. Each level is calculated with data gathered on seven public health indicators.

As of late last week, new public health data led the Ohio Department of Health to designate 12 counties as being in a Red Alert Level 3 Public Emergency as defined by the Ohio Public Health Advisory System. In addition to social distancing and wearing a face covering, other guidelines for a Red Alert Level 3 are:

- (1) Decrease in-person interactions with others;
- (2) Consider necessary travel only; and

In light of local conditions and developments, and in consultation with criminal justice stakeholders, including the Hamilton County Prosecutor, City Prosecutor, Public Defender, and Sheriff, the Courts are temporarily pausing jury trials (petit jury service) to facilitate the recommended public health emergency guidelines. The Courts will continue to monitor this fluid situation and will resume jury trials when conditions in Hamilton County improve.

Hamilton County Prosecutor Joe Deters said, "I agree with the court's decision today to suspend jury trials. Unfortunately, with the spike in the number of coronavirus cases in Hamilton County, it is not reasonable or safe to ask citizens to come down to sit on juries. We also must be concerned with the health of all of the attorneys involved in these cases, courtroom personnel, witnesses and defendants. While no one wants to postpone cases any longer than necessary, this is a matter of public health."

The Courts remain open for most proceedings. Grand jury proceedings will continue while petit juries (jury trials) will temporarily be on hold.

If you have been summoned for jury duty, please review your summons. Below the bar code, your summons will indicate "grand" or "petit." Those summoned for Grand Jury should continue to report as scheduled. If your summons indicates, "petit," please follow reporting instructions carefully before appearing in-person. Reporting instructions can be found on our website at www.hamiltoncountycourts.org/juryduty or call the Juror Hotline at 513-946-5879. The recording starts immediately.
