**ORDER** 

In response to the public health crisis created by COVID-19 and the actions taken by federal, state, and local officials, the Hamilton County Court of Common Pleas, General Division and the Hamilton County Municipal Court (the "Courts") have implemented a number of safety measures through a series of Administrative Orders¹ in an effort to maintain Court functions while complying with public health orders and guidelines.

On May 14, 2021, Ohio Governor Mike DeWine issued a statement directing the Ohio Department of Health to conform the remaining health orders to CDC guidance through June 2 Specifically:

"Ohio will be amending our remaining health orders to comply with the new CDC guidance, which says that those who have been vaccinated no longer need to wear masks, while those who have not been vaccinated should still wear a mask and socially distance."

The Courts have also taken into consideration guidance from Ohio Supreme Court Chief Justice O'Connor to "continue to operate within the directives of the Governor and the Director of Health."<sup>2</sup>

Accordingly, to further serve the community and in accordance with the most updated guidance from the CDC and Ohio Public Health, effective immediately and until further order, the Courts modify their previous COVID-19 related Administrative Orders as follows:

1. This Joint Amended Administrative Order applies to all Court Facilities. For purposes of this order, "Court Facilities" includes the Hamilton County Courthouse at 1000 Main Street (Courthouse), and to Common Pleas, General Division and Municipal Court employees who work in the Hamilton County Justice Center at 1000 Sycamore Street (Justice Center). With regard to any Municipal Court employees or employees of the General Division of Common Pleas who work

at 800 Broadway, or any person doing business with such employees, while in that building, those individuals shall follow the directives of the Domestic Relations and Juvenile Court Divisions.

- 2. Anyone entering Court Facilities under this Joint Amended Administrative Order is not required to wear a facial covering.
  - a. For purposes of this Order, a facial covering is a face covering or mask made of cloth or a similar material that covers the nose, mouth, and chin at all times, and is separate and apart from one's clothing, and does not obscure the identity of the person.
  - b. Individuals who wish to wear a face covering for personal health reasons shall be permitted to do so. Individuals may be asked by a judge to remove their face covering if necessary for hearing purposes.
- 3. Consistent with public health guidelines, individuals who are not fully vaccinated, including children under 12, remain at risk, and are strongly encouraged to wear a face covering and observe physical distancing, keeping a minimum of six (6) feet of distance between people, at all times in all areas.
  - a. For purposes of this order, individuals are considered fully vaccinated for COVID-19 two weeks after they have received the second dose in a two-dose series, or two weeks after they have received a single-dose vaccine.
  - b. Unvaccinated people refers to individuals of all ages, including children, that have not completed a vaccination series or received a single-dose vaccine.
- 4. Each Common Pleas and Municipal Court judge retains the authority to establish their own, more restrictive standards within their courtroom and adjoining offices including capacity, social distancing, and mask policies.
  - a. To the extent a Judge requires the use of a face covering in their courtroom, a face covering or mask shall be provided by the Court.
  - b. COVID Jury Trial rooms, outfitted to comply with previous health guidelines, will continue to be available to Judges who wish to conduct jury trials in a more protected setting.
- 5. Previous limitations on in-person access to Court Facilities, which were necessary to limit large gatherings, are hereby lifted. Judges are encouraged, however, to continue to stagger dockets and utilize remote hearing capabilities where possible.

- 6. Given the continued threat posed by COVID-19 to unvaccinated, immunocompromised, and other individuals, Judges are strongly encouraged to utilizing remote hearing capabilities or liberally grant continuances to accommodate those with ongoing COVID-19 related personal health concerns.
- 7. Electronic filing through the Clerk of Courts e-filing portal is encouraged for all filings where possible.
- 8. The availability of hand sanitizers and regular cleaning in common areas shall be maintained.
- 9. No person shall enter Court Facilities, including all Hamilton County elected officials, county and Court employees, contractors, and anyone seeking to participate in or attend a Court proceeding if:
  - a. Without regard to vaccination status:
    - i. They have COVID-19 or believe they have COVID-19, or;
    - ii. They exhibit signs of respiratory infection (cough, fever, shortness of breath). Such individuals seeking to attend a court hearing shall be instructed to call their attorney or the courtroom staff of the judge presiding over the proceedings.
  - b. They are an unvaccinated person, and
    - i. Within the last 14 days, have been exposed to someone suspected or confirmed to have COVID-19, or;
    - ii. They are awaiting a COVID-19 test result.
  - c. The Hamilton County Sheriff and his or her Deputies and other agents shall not be liable for anyone admitted or denied access to Court Facilities regardless of such person's medical health.
- 10. Unvaccinated employees must perform a daily symptom assessment before coming to work and are strongly encouraged to wear a facial covering and observe physical distancing in all areas of Court Facilities except in their private office space. Employees must stay at home if they develop a fever or exhibit signs of a respiratory infection.
- 11. This Joint Amended Administrative Order is effective immediately and until further order of the Courts. To the extent this Order conflicts with any of the

Courts' previous COVID-19 related Administrative Orders, this Amended Joint Administrative Order supersedes.
